The award recognizes achievements/accomplishments, not longevity and/or effort; it recognizes a life or career-long record of accomplishments. It is not given for a "one-time" achievement.

Your nominee must be living at the time of nomination and must be a U.S. citizen. Nominee's personal and/or professional record shall not have unverified or verified allegations that would tarnish the reputation of the Honorable Cornelius Amory Pugsley Medal. And a nominee may only be considered twice within a five-year period. The Pugsley Medal will be awarded at the Academy's annual awards banquet or virtually.
